In March, 1981, Brother Pablo Basterrechea, Superior General, will come from Rome for a provincial celebration at St. Mary's Cathedral, San Francisco.


The Alumni Association of St. Mary's College is honoring the Brothers with a civic banquet in San Francisco on October 24, 1980.

Development Program Continues With Annual Giving Appeal

In this issue of the CONNECTION is a financial report on the initial phase of the Development Program inaugurated by the Board of Regents in May, 1978.

The first appeal had a goal of \$300,000 to aid the school for 1977-78, 1978-79 and 1979-80.

With the payment of current pledges, this goal will have been reached. However, with continuing inflation, the gap between the tuition fee and the cost-per-student is a constant need that must be bridged.

Tuition realizes 55% of the school's revenue; subsidies from the San Francisco Province of the Christian Brothers and diocese of Sacramento account for approximately 25%; support groups as the La Salle Club, Parents' Service Organization and Band Boosters, along with auxiliary services such as the bookstore, cafeteria, etc. bring in about 10% of the needed revenue. The remaining gap of 15% is the goal of the Development Program.

Appeals are being made for an annual giving plan for scholarships, grants-in-aid and contributions towards the operating deficit to offset further increases in tuition.

Donors are being sought among the alumni, parents of students, friends and business firms interested in helping the Christian Brothers to continue their services to the youth of Sacramento in a Catholic high school.

Development Program Aids Scholarships And Tuition Assistance

Five students have been granted Merit Scholarships, a program which recognizes students who demonstrate outstanding academic potential.

Two sophomores, Fernando Erisman and David Maes have earned their second year of scholarship.

Three freshmen were winners of this year's awards: Theodore Coe has a full tuition four-year scholarship, Harlan Imberg and Michael Roche have half-tuition four-year scholarships.

Winners of these scholarships, sponsored by the Board of Regents through the Development Program, are expected to maintain a 3.0 grade point average each semester of attendance.

Tuition assistance is provided also to families who demonstrate a need for grants-in-aid,

For 1980-81, the Development Program expects to provide \$16,000 for scholarships and tuition assistance.

This contribution is realized from the interest on invested funds from endowed and memorial scholarships.
