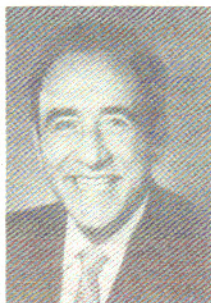
Summer School for Boys & Girls at CB

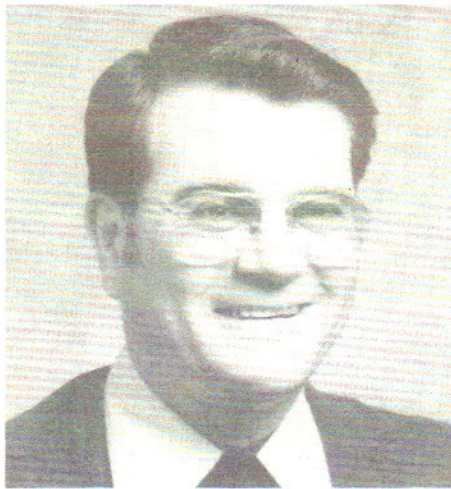

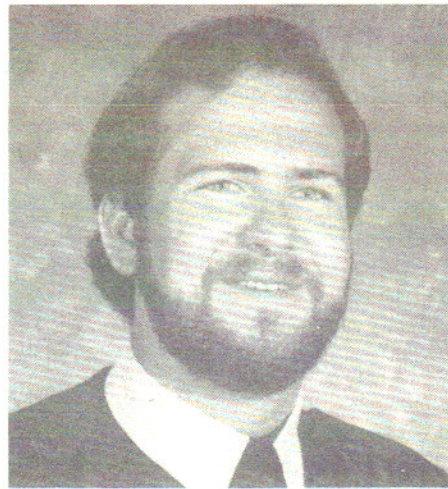
