### Pat O'Brien to Celebrate His Beginnings at CBS

Pat O'Brien. Guidance Director at Christian Brothers High School, will begin the silver anniversary of his first assignment in Sacramento at Bishop High Armstrong School with the completion of the current semester.



Pat was born and raised in the Mission District of San Francisco. Prior to high schol he attended St. Mary's in Berkeley and along with his high school buddy, Brother Bede, he decided to become a Brother. He attended Mont La Salle High School and St. Mary's College, graduating in January, 1955 with a degree in English.

He began his teaching career at Cathedral High School in Los Angeles, working under Brother Bertam, Principal and Brother Edward, Vice-Principal, both members of the current CB staff. During these teaching years, Pat taught English, religion and journalism, moderated the award winning newspaper and coached the basketball and baseball teams. Assignments followed at Bishop Armstrong High School (1960-62) and Moraga (1962-68) as Vocation Director for the Brothers.

Following grad school at San Diego State in counseling, Pat left the Brothers only to accept a counseling job at CBS in 1970. Sometimes he asks himself what life might have been like if he had accepted a position at that time at Leeward Community College in Hawaii.

Before returning to CBS, Pat married Billie and they now have three children: Brigit (13), Colleen (10) and Patrick Sean (4).

Pat was honored in 1959 by the Wall Street Journal's Newspaper Fund when he was selected for a competitive scholarship to Marquette University in Wisconsin for journalism studies. He (continued on pg 5)
