Mr. John Higgins, Career Counsellor for the Guidance Department, will coordinate the school's participation in

the program.

The entire school day is set aside for students to meet with men and women in at least four distinct job opportunities.

While some career areas have limited speakers available among the alumni to have a different presenter each year, other areas have allowed for variety of persons to meet with a student over his four years experience of Career Days.

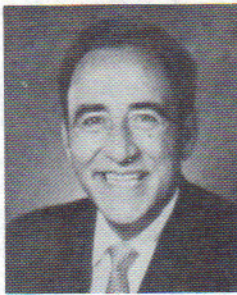
in carrying out their mission at Christian Brothers High School.

## La Salle Club Pays Tribute

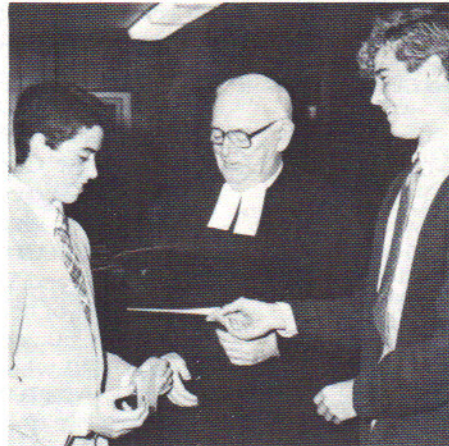
