

Re: Dissolution of Debt
From: Brother S. Martin, FSC, Principal
Date: April 4, 1973

In 1970, the La Salle Club of Christian Brothers High School requested and received a loan of \$30,000 to underwrite their work on the athletic field facilities of Christian Brothers High School, Sacramento. At this time I am asking that the La Salle Club debt of \$12,000 be dissolved by the District Council. My reasons for this request are as follows:

- 1) The La Salle Club came to the Council and asked for a loan, not a contribution, for their project in irrigating the athletic fields and the development of two complete baseball diamonds and a soccer field on currently un-developed property on the campus.
- 2) The La Salle Club has repaid all but \$12,000 of that loan, as per agreement with the Council. The Club has also put \$34,000 of their own money, plus many man-hours, into that project. The La Salle Club members have worked on digging the trenches themselves, have worked at clearing the properties - both efforts effecting a reduction in the total cost of the project.
- 3) Additionally, over the years the La Salle Club has contributed to the development of athletic-physical educational programs and facilities here at the school. For example, they pay the \$3800 stipend for coaches salaries. During the course of the year, the Club sponsors a raffle, a dinner, a Christmas dance, a baseball night and a golf tournament and fireworks stand to raise this money. All their money goes into projects and assistance here.

On the basis of past history of contributions, and as a basis of encouragement for continued support for the athletic program here at the school, I feel that the La Salle Club debt of \$12,000 should be dissolved in favor of the Club as an earnest of the appreciation of the school and the District for their work, their involvement and financial support of this aspect of the school program.

Dear Mr. Luzzi and Members of the La Salle Club:

For many years the La Salle Club since its beginnings has been very devoted to the welfare of Christian Brothers High School particularly in the field of athletics. For this, I as Provincial of the San Francisco District of the Christian Brothers, and the many Brothers who taught at Christian Brothers High School are very grateful to you gentlemen. It has not only been your financial assistance to further the athletic and physical education programs at C.B.H.S. but the man-hours of physical effort and work you have put into your projects that calls for our gratitude to you.

In 1970 when you decided to take on the great project of improving and enlarging the athletic field facilities you requested a loan of \$30,000 from De La Salle Institute to assist you in financing the project. The loan was agreed to by De La Salle Institute with the stipulation that it be paid off in a maximum of five years. To date \$18,000 of the loan has been repaid to De La Salle Institute.

It has been brought to our attention that the La Salle Club has given \$34,000 of their own funds, plus many man-hours, into the project and has sponsored numerous events to finance not only this project but others at Christian Brothers High School.

On the basis of past history of contributions, and as a basis of encouragement for continued support for the athletic program, Brother Martin Fallin, Principal of Christian Brothers High School, petitioned the members of the District Council that the La Salle Club debt of \$12,000 be dissolved in favor of the Club as an earnest of the appreciation of the school and the District for their work, their involvement and financial support of this aspect of the school program.

At its meeting of April 13, 1973, the District Council voted unanimously to accept the petition of Brother Martin Fallin to dissolve the La Salle Club debt of \$12,000 to De La Salle Institute in favor of the La Salle Club. This letter will serve to notify you that the debt has been canceled.

May the Good Lord bless you for all your efforts in the past and the future for the benefit of Christian Brothers High School.
