- 1941 C. Stanley Gilliam, B. A. St. Mary's, attended Cal-Berkeley and San Jose for graduate studies, M. A. Sacramento, wife Joan, children John A. '69, Ann Dolora Banks, Stuart Charles '76. Columnist for Sacramento Bee. He says that the most important thing he ever did in his life was to marry Joan and the next important things were to attend Christian Brothers and to send his two sons to Brothers.
- 1942 James D. Coyle A. B. Stanford and M. D. Stanford 1948. Wife Herta and children James D. III in USC Dental School, Robert R. an airline pilot, Daniel J. pre-law student at University of California, Davis. He is associated with his brother Richard '48 in the practice of medicine. Their father James D. Coyle graduated from Brothers in 1910.
